The Samuel and Isabel Small Legacy Society

The Samuel and Isabel Small Legacy Society recognizes individuals who have provided for the future of WellSpan Health in York County through a financial or estate plan.

Samuel was a distinguished leader in York County. He was a

director of York's first building association and of the York and Cumberland Railroad. But he is better known for his heart. He cared deeply for the health and welfare of his community. He founded the York Benevolent Association in 1863, the York Children's Home for orphans of soldiers two years later and the York Collegiate Institute. In 1879, he led a group of philanthropists in founding York Hospital.

Isabel was the daughter of a prominent attorney. A woman of rare intellect, she too is remembered for her heart for others.

She organized the women of York to aid wounded soldiers during the Civil War by providing bandages and sewing clothing. She donated and bequeathed substantial resources to benevolent organizations.

WellSpan York Hospital stands as a memorial to the care of Samuel and Isabel for those in need of health care. Their generosity touched many children and adults throughout the county during their lifetime; a legacy that continues to impact our community in profoundly important ways 140 years later.

Supporting WellSpan York Hospital, or one of its related institutions, through WellSpan York Health Foundation with an estate or other planned gift, will ensure this continued legacy of improving the health and wellbeing of residents of York County for our children, grandchildren and future generations.



The Anna Huber Legacy Society

The Anna Huber Legacy Society recognizes individuals who have provided for the future of WellSpan VNA Home Care through their financial or estate plan.

This society is named in honor of the founder of VNA Home Care (previously Visiting Nurses Association), Anna M. L. Huber. Born in 1874, Ms. Huber began a long and dedicated campaign to improve York's community health care for all residents. In 1904, she helped organize the St. Anne's Guild to sew for the poor in the maternity ward of York Hospital. In 1907, the group decided to start a district nursing program. One year later,

the first visiting nurse began practicing in York. Anna Huber became the VNA's first President and served in that role for 48 years. She was an excellent organizer and an avid fundraiser.

Supporting WellSpan VNA through WellSpan York Health Foundation with an estate or other planned gift will ensure that Ms. Huber's vision of serving all of those in need will continue for future generations.

Be efficient with your taxes.

Planned Giving tools offer a number of ways to be taxefficient with your assets and financial planning. Gifts may allow for immediate tax deductions, a reduction of capital gains taxes when applicable, and ways for beneficiaries like heirs and non-profits to make the most of the gifts received. Some of the Easiest Ways to Make an Impact

Bequests

A bequest is the most common way of leaving a legacy. A bequest is a gift of cash, securities or other property designated via an estate plan.

- Make a bequest to WellSpan York
 Health Foundation in your will or trust
 (a specific dollar amount or asset, a
 percentage of your estate, or a gift of the
 balance of your estate);
- Leave all or part of your retirement assets to WellSpan York Health Foundation; or
- Name WellSpan York Health Foundation as owner or beneficiary of a life insurance policy.

Change of Beneficiary Form

Filling out a "Change of Beneficiary Form" for a retirement account or life insurance policy is a simple process, not requiring changes to your will or trust. More importantly, retirement plans (IRA, 401k, 403b, pension or other deferred plans) are

often the largest assets in your estate – and the most heavily taxed. If you leave these funds to someone other than a spouse, a large portion of these assets might be lost. Simply complete a change of beneficiary form to leave all or a portion of the plan to WellSpan York Health Foundation. WellSpan York Health Foundation gets the full value of these funds.

Life Insurance

A gift of life insurance to WellSpan York Health Foundation is a great way to establish a legacy. There are several options:

Donate a paid-up policy that you do not need as an immediate gift;

Change the beneficiary designation of a current policy for a future gift to WellSpan York Health Foundation; or

Purchase a new policy and name WellSpan York Health Foundation as owner and beneficiary.

Gifts from your IRA

You do not need to delay a gift from your IRA. The now-permanent Charitable IRA Rollover allows you to satisfy your required minimum distribution, substantially reduce taxable income and support WellSpan York Health Foundation. If you are over age 70½, you can donate up to \$100,000 from your IRA to WellSpan York Health Foundation, avoiding any federal income tax on these funds. Our office can assist you with language for requesting your fund administrator to effect this donation.

Transfer of Other Assets

Common bank accounts (i.e., checking, savings and money market accounts) can be transferred to a beneficiary by completing a "payable on death" (POD) form. This allows assets to transfer outside the probate process.

A similar method using a "transfer on death" (TOD) form is typically used for stocks, bonds, brokerage accounts, mutual funds and real estate.

Real Estate

A gift of your appreciated property – such as your home, vacation property, vacant land, farmland or commercial property – may be an ideal way for you to leave a lasting legacy.



Private Business Interests

Donating appreciated stock or bonds is a common and easy way to benefit our mission. It is also possible to donate all or a portion of privately held business interests. This takes more discussion with and assistance from relevant financial and legal professionals. But yes, it is possible, and can make a wonderful gift!



Farm Commodities

Make a gift of what you grow and harvest, from farm crops like grain to animal products like dairy, honey and more. You can deduct the cost of production from your taxes and you may qualify for other tax benefits as well. What a creative opportunity.

Charitable Gift Annuities

A Charitable Gift Annuity offers you steady payments for life with funds eventually going to WellSpan York Health Foundation. This can add an extra measure of financial security in your retirement.

You can use a range of assets (cash, stocks, bonds, commodities, retirement assets and more). You may be able to deduct a significant part of your gift immediately and part of the annuity payments you receive may be tax-free.

A deferred annuity can increase the annuity payments. Charitable Annuity Trusts offer additional flexibility depending on your needs.

Chloe Eichelberger's near-death experience motivated her to include WellSpan York Hospital in her estate plans. "John Lennon famously paraphrased American journalist and writer Allen Saunders in his 1980 recording of Beautiful Boy: 'Life is what happens while you're busy making plans.' On a wintry morning in February 1984 that prophetic line came to life for me.

"Following an accident which left me trapped in my car for four hours, under a burning trailer which had overturned on my car, I was ultimately freed by the grace of God working through some amazing first responders and

firefighters. Then I was rushed to WellSpan York Hospital to begin what would be a 57-day battle for my life.
